Background:

The General Services Administration (GSA), Information Technology Category (ITC), IT Schedule 70 has established a single award Blanket Purchase Agreement in accordance with the ordering procurers of FAR 8.405-3(b)(1) for laptops, desktops, tablets, monitors under Government-wide Strategic Solutions (GSS).

Scope:

The fundamental scope of the GSA AdvantageSelect BPAs is to provide a streamlined process and leverage the government's buying power for procuring laptops, desktops, peripherals, ancillary supplies/services. The BPAs will be available for use by federal (both civilian and military) as well as State, Local and Tribal governments through the GSA Cooperative Purchasing Program.

To Order Online:

1. Go to the GSA Advantage Select Page for HP products: <https://www.gsaadvantage.gov/advantage>
2. Find the products that meet your requirements, configure your item as desired, add to cart and either checkout or add other items using the same process.
3. **For quantities of over 30 units it is recommended to contact the vendor and ask for additional discounts** - a discount code can be used at checkout and the agreed to price manually entered.
4. If payment is being made via the Address Activity Code for civilian agencies or purchase card, please see link on processing order via GSA AdvantageSelect.
5. If payment is not being made via the Address Activity Code or purchase card, ordering activities may order directly from vendor via their agency contracting writing systems.

To Order Direct:

1. Contact the BPA Holder using the information above, provide your requirements and ask for an all-inclusive quote. **For quantities of over 30 units it is recommended to ask for additional discounts.**
2. Once the quote is received, check to ensure all prices are equal to or less than their BPA pricing.
3. Issue your order.
